INTRODUCTION

Yesterday, Crisis Centre announced Lee Harvey Oswald had been shot to death by Jack Ruby who stated he made a murder crime in name of his nation. Some delegates support it, but some others, such as Lyndon B. Johnson and Howard Brennan, say human rights are for all and, even Oswald could be the responsible, there is no justification for murder him. Today, delegates continue postulating theories. Could be Oswald be considered as a good source of evidence? Did Jack Ruby ruined the investigation? Which is the most viable theory?

MODEL DEVELOPMENT

Day 2 begins. Delegates started presenting their theories discussed throughout the blocks highlighting the main question imposed by Richard B Bussel at the end of his presentation: who? Upgoing, George De Mohrenschildt state his agreement with the assassination of Kennedy in hands of the USSR and Cuba, who states the U.S. discovered nuclear missiles in Cuba and, in response, the communist party send someone to kill Kennedy. Once the presentation ended, John Sherman initiates his intervention with: "I have a theory, what if Jack Ruby was the other shooter?". Sherman states Ruby was the other shooter who lied about killing Oswald in the name of his nation, but, because he was scared of being revealed, decided to shoot Oswald, imposing a new theory over who was the second shooter. Clint Hill supports Sherman as she considers Oswald was a key source of information for the case as well as accusing Lyndon B. Johnson to be involved in the incident. Jack Ruby responds: "My actions were not more than for the Americans". He accepts the idea Oswald may not be the unique shooter, but states his actions weren't made to cover him from what he's being accused of. Howard Brennan maintains his position in favor of Oswald's as a main assassin. He summarized the incident exposing Oswald as the main and unique suspect with images that reveals the possible actions taken by Oswald after he shot and mentions only one bullet was involved in the incident which impacted both the Governor and the President. Also, presents relevant images of how Oswald had a rifle similar to the one found in the Texas School as well as the bullet he used was very suitable for the range distance involved in the assassination. Once Brennan ended, a new crisis was announced: information evidenced Oswald had connections with KGB and Jack Ruby was mysteriously murdered. Furthermore, Moscu and Washington's connections totally collapsed approaching to a nuclear war involving a peace summit to avoid a possible WWII. Finally, important information revealed the CIA may be involved, if this is true, a civil war may occur within the U.S. territory. John Conally, who is still recovering from his injury, responds to the dais questions based on the incident who explains what he heard and saw. "All the shots seem to come from the same position, over my shoulder" - said Conally. He had no knowledge of any member related with Lee Harvey Oswald nor who was he. Lyndal highlight the fact of avoid ignoring the facts the have just given and Gerald mentions the importance of arriving to a solution, such is the case of a possible WWII.

A Press Release arrived to the committee: 2:15 a.m., December 6/1963, Jack Ruby was found dead at Cadillac Fleetwood. A 22 caliber handgun was fired. Charles "Chuckie" Nocilletti, and Felix "Milwaukee Phill" Alderisio were the assassins of Jack Ruby who suffered of a trauma leading to an instant death. To summarize, the Italian Mafia was responsible of the killing of Jack Ruby. "La famiglia ti manda I suoi salut", both said to Ruby. Continuing, Lyndall begun to interview Abraham Zapruder about the incident as he was one of the witnesses involved. Lyndall ask him about how did he get the video of Kennedy. Lyndall focused on what happened during the video taking including what he had heard during the shooting. "I never even heard a third shot...I also though it come from the back of me", said Abraham in response to what he heard. Lyndall closes saying Abraham contradicts himself based on what he state yesterday and his testimony today, stating he hadn't any perception of the bullet's sound which means delegates can't assume what he said yesterday was correct.

CLOSURE

As the day comes to an end, delegates had the option to intervene to reformulate their theories with the new evidence presented as well as the crisis currently ongoing throughout the commission. Between the delegates' interventions, Lyndon B. Johnson believes one of the delegates was the responsible of sending the Mafia to kill Jack Ruby. Some delegates believe Oswald was the shooter who was send by the Soviet Union. Most delegates agree in Lee Harvey Oswald as the shooter of the incident; however, they differ in who was the master mind or if they were two shooters. Lyndall Shaneyfelt calls delegates to investigate other agencies and the USSR and avoid maintaining their position in mere theories. During the interventions, many of the delegates coincide in two important theories: the Soviet Union as the responsible as well as the two shooters theory alike Howard Brennan who supports the idea of a unique shooter. Additionally, Earl Warren highlights his concernation over the pure conspiracy and assumptions within the delegates, mentions the significance of the possible WWII upcoming situation and calls delegates to support on proofs and evidence supporting Lyndall statement. Nevertheless, Hale Boggs state: "why they killed Jack Ruby?", mentioning the importance behind the significant death of Jack Ruby as well as Oswald's death. "Who will be the next?" - says Boggs to achieve the attention of delegates towards the mysterious assassinations. Will more delegates die to cover the truth?
