INTRODUCTION

U.S. is in khaos. Population shocked. Warren Commission is stablished and initiates the investigation. John F. Kennedy has been shot during his presidential visit at Dallas, Texas. A rifle was found at the sixth floor of the Texas school. Warren Commission has as a main suspect: Lee Harvey Oswald. Press around the world imposes many questions to the population: did the shooter act alone? How did he shoot from the long distance registered? Who is John F. Kennedy's true assasin?

MODEL DEVELOPMENT

The commission begins with the summary of the fatal incident on November 12, 1963 dictated by the dias. The dias annonces the investigation initiation through which delegates would be involved in evidence research, and interviews to witnesses and possible suspects accompanied by the upcoming opening statements of each of the delegates which mentions their position over the topic whether if they are innocent, and who do they blame. Those who are suspects, sustain their position over the lack of proofs which mainly upcome from conspiracy theories and how is impossible to determain their culpability including Oswald whose mission by his own words is "proof my innocence". Even the existence of possible disagreements within the delegates, all have state their same purpose at the commission: find the responsible behind the assassination of John F. Kennedy.

"I would like to refer to Lee Harvey Oswald": initial words of Howard Brennan to start the informal debate. Howards Brennan witnessed a suspect at the Texas School. He started the investigation based on the height of the shooter which casually coincide with Oswald's body. Lyndal Shaynefelt agrees with Howard. Based on the accusations, Oswald responds: "Who is more possible: a 24 year-old man with a wife and sons, or the CIA and FBI who had direct relation with the President?", directly accusing the CIA and FBI as the responsibles of the assassination. Oswald says his co-workers could confirm his alibi and the CIA would have enough reasons (related to the Pig Bay invasion) to kill John F. Kennedy. Most delegates maintain their position against Oswald, however, Hale Poggs retrieves a new theory exposing two possible suspects: one shooter from behind and another one from the front. Upon the highlight of Edgar Hoover, delegates begun to consider other theories and suspects further than Oswald including Jack Ruby, who highlights the significance of Lyndon B. Johnson as a suspect. Lyndon B. Johnson responds to several questions within he specifies his alibi and highlights his friendly relation with John F. Kennedy. Some delegates such as John Sherman and Jack Ruby doubt about Johnson's true relation with Kennedy. After the 30 minutes debate, Lyndall specifies the significance of evidence in the case in whichi she states delegates are deviating from the central topic. Additionally, Gerald Ford mentions Johnson's accusations to the CIA are a total disrespectful as he is accussing his own country and recovers the idea of Oswald as the unique assassin. Jack Ruby asks: "Do you have any evidence it was not Lyndon B. Johnson?", where Gerald Ford responds it was impossible for the President to shoot. Along the debate, Richard B. Bussell states the current situation of the U.S. and the Soviet Union including the forensic description of Kennedy's body as he considers an event with such a high magnitude can't be done by a uniqu

CLOSURE

Directives begun within the commission. Around the committee, there are four blocks, each one with a different theory to develop including their own evidence and suspects. Howard Brennan's block mentions there was only one shooter involved who was Lee Harvey Oswald, theory which also coincides with George De Mohrenschidelt's block. However, this block has another theory which involves the send of a shooter from the Soviet Union and Cuba based on the historical context between the U.S. and USSR. John Sherman's block state there were two shooters and the involvement of Lyndon B. Johnson as one of the responsibles. Finally, Lee Harvey Oswald's block defend their position that Oswald wasn't the shooter, but the government (CIA and FBI) who were dissatisfied with Kennedy's government. Howard's block has the model representation video of the incident created bsed on the description of the incident which supports his theory. Sherman's block obtained the autopsy and ballistic report as well as the video which may proof two bullets involved in the incident. Oswald's block is based on a witness system with a key witness: Abraham Zapruder. On the other hand, George's block will send a directive to obtain enough evidence which supports their theory. As the debate ends, each block begins to present the evidence they have discussed within their Lobby time discussing who could be the responsible.
